Budget Discussion

200-1 PTA Membership

Dues are now \$0.75 per member to county and \$5.25 per member to state (last year state charged \$3.25).

How hard should we push for members? Should we charge the same \$10, more, or less? Consensus seems to be charge the same, but we don't feel the need to push for members as hard this year. There is no minimum threshold we need to meet, and the income is small compared to our other fundraisers.

Should we stay with PTA affiliation or switch to PTO affiliation (cheaper)? But we would still owe everything for this year. Switching to PTO would be a paperwork nightmare. Consensus seems to be to stay with PTA affiliation for now.

200-5 School Spiritwear Mechandise Income

Tammy proposed buying some extra shirts to offer at the back to school bash. We could sell them at a mark-up. Dana suggested buying just the kids sizes -- 5 of each kids size. Just one design. The horse is the most popular design.

It was suggested we open up the BJ storefront again in November, before Christmas, when people are spending money. This was not decided on for certain. We'll revisit this again at a later meeting.

250-3 and 250-4

These are both donation based, so we don't know what to project.

250-6 Play Production income

This year we're having the concessions donated instead of buying them. Leave at \$13,000.

250-7 Theatre Arts Program income

We're still doing theatre arts with Behind the Curtain program, but they're not collaborating with the MET this time

The Behind the Curtain program is asking for \$500.

Change to \$500. Also change 750-7 to \$500 so it's a wash.

750-5 Holiday Gift shop expenses

We have a lot of existing product. Change to \$6,000.

750-6 Play Production expenses

Play budget had money for concessions last year, but this year we will move back to prior model (prior to last year) of family donated concessions. **Change to \$10,000.**

775-1 Chess Club

We use an outside company to run the chess club, and it's expensive, so we're going to cap the club at 12 students per session and pay half of the cost for each student (which is \$80). We'll run the club two times -- once in the fall and once in the spring. **Change to \$2,000.**
